Background

- Pressing social justice issue
- Policy & systems barriers
- Few specialty-trained medical providers (Bakko & Kattari, 2021)
- Legislation to restrict care (Conron et al., 2021; Walch et al., 2021)





Gaps in the Literature

- Minimal info about access to and outcomes of healthcare (McDowell & Dowshen, 2021)
 - Even less for BIPOC (Chen et al., 2020)
- Minimal info about those who discontinue care
- Lacks clear & consistent terms (Butler & Hutchinson, 2020; Steensma & Cohen-Kettenis, 2018; Temple Newhook et al., 2018)
 - Desistence, Detransition, Discontinue





• Assumption that discontinuing care = desistence/detransition (Butler & Hutchinson, 2020; Expósito-Campos, 2020; Steensma et al., 2013; Temple Newhook et al., 2018)

- Barriers to care (Daley et al., 2019; Temple Newhook et al., 2018; Turban & Ehrensaft, 2018)
- "Detransitioning" (Giordano et al., 2021; Mccallion et al., 2021)

No studies that specifically differentiate between TGD youth who choose to detransition from those who discontinue care due to factors unrelated to gender dysphoria.


Aims & Hypotheses

- 1. Report basic characteristics of TGD youth who discontinue medical care as compared to those who continue medical care.
- 2. Report rates and purpose of discontinuation of care, including detransition rates.
- 3. Describe the well-being of TGD youth who discontinue medical care compared to those who continue medical care.
 - 1. TGD youth and their parents who continue care will have higher PedsQL well-being scores than those who discontinue care
- 4. Describe the health status of TGD youth who discontinue medical care compared to those who continue medical care.
 - 1. TGD youth will have higher BMI than a comparative normative sample, and TGD youth who discontinue care will have higher BMI, more diagnoses, and more prescribed medications than those who continue care.



Importance

- Evidence-based answers
- Inform healthcare guidelines
- Advise parents
- Inform legislation





Inclusion Criteria

- Presented to Gender Pathway Services between 2014-2021
- At least 8 years old
- Parent or caregiver present
- Previous Gender Dysphoria diagnosis




Measures

• EMR

- Patient demographic data
- Medical information
- Reason for discontinuing care
- Clinic REDCap
 - General Well-Being Scale of the Pediatric Quality of Life Inventory



Virtual Follow-Ups

- 124 met criteria for virtual follow-ups
 - 71 contacted, 52 remaining to contact
 - 16 parent & 15 patient appointments completed
 - Goal was 30 participants
- REDCap Survey (parents and children)
 - Demographics, family environment, gender dysphoria, health and healthcare, barriers to care
- Interview
 - Current healthcare status and providers, reason for discontinuing

Problems

- Low motivation to participate
 \$30 per virtual follow-up
- Not answering the phone! (Ellis et al., 2021; Kempf & Remington, 2007)
- Multiple respondents (Alexander et al., 2017)
